

One Travel Team Membership Agreement Terms and Conditions

Terms and their meanings:

"Collaborator" means a contracted by One Travel Team, LLC third party that provides the privileges, benefits and services to our members.

"Internet Portal" means the website owned and operated by One Travel Team, LLC such as www.onetravelteam.com or any subdomains of this Web site or any other Web sites, including sub-areas through which One Travel Team may offer access to the benefits, privileges and services.

"Member" means a physical person (no business entity can become a member) who was accepted to a club by One Travel Team as a participant and who paid membership fee. The Membership will terminate if the person decides to terminate or the Company decides to terminate.

"Membership Application" means application form in paper or electronic format that filled out by perspective applicant. Application will be reviewed and approved or rejected by One Travel Team

"Membership" means participation in the Member only program, which grants Members access to the privileges and services offered by One Travel Team and its Vendors and Collaborators.

"Voyago Economy Membership" means access to a group trips such as All Inclusive, Cruises, Eco Tours, Excursions and other trips available for booking only for the Members for specific dates to a specific destinations. Most of the times, discounted rate will apply for the group booking. As a Voyago Economy Member, you will pay (\$50) fifty dollars administrative fee for each booking.

"Voyago Black Diamond Membership" means access to a group trips such as All Inclusive, Cruises, Eco Tours, Excursions and other trips available for booking only for the Members for specific dates to a specific destinations. Most of the times, discounted rate will apply for the group booking. As a Voyago Black Diamond Member, you are exempt from paying (\$50) fifty dollars administrative fee for each booking.

"VoyagoPro Membership" means access to the booking platform at any time for the discounted or net rates for the Members. You can book any trip you like for any dates as a VoyagoPro Member. You can combine VoyagoPro membership with Voyago Economy or Voyago Black Diamond membership.

"Voyago Economy Membership Fee" means a payment of (\$150) one hundred and fifty dollars to purchase Voyago Economy Membership to become a Member. Fees are due on acceptance day. This fee paid only ones.

"Voyago Black Diamond Membership Fee" means a payment of (\$300) three hundred dollars to purchase Voyago Black Diamond Membership to become a Member. Fees are due on acceptance day. This fee paid only ones.

"VoyagoPro Membership Monthly Membership Fee" means (\$20) twenty dollars monthly payment made by the Members to gain and maintain access to benefits and privileges offered by Voyago Pro Membership package.

"Membership package" means specific offering of the services and privileges associated with the level of the Membership.

"One Travel Team, Company or We" mean One Travel Team, LLC, a limited liability company registered in Arizona

"Privilege" means permission to use of special products, offers, services and benefits provided by One Travel Team, LLC or/and its Vendors and Collaborators. Privileges will depend on the level of membership chosen. Privileges may include discounted trips, special reduced rates, net rates, special offers, exclusive members only products and prices and other products and services provided by One Travel Team and its' Collaborators and Vendors.

All provisions stated in these Terms and Conditions will govern and serve as guidelines for the Members who have chosen to take part in the One Travel Team Membership and use of the privileges of the Membership at any level of their choice (Voyago Economy, Voyago Black Diamond or VoyagoPro).

Our Rights of Rejection:

We reserve the right to reject any perspective applicant for membership at our own discretion.

Validity of the Membership: Membership will become valid only after One Travel Team accepts the membership application, the membership fee is paid by you and received by One Travel Team, and you accepted the Terms and Conditions on your first visit to the Internet Portal. Continuation of VoyagoPro Membership always conditional upon payment by you of the VoyagoPro Monthly Membership Fee.

Age requirements to become a Member: To join the program as a Member minimum age requirement is 18 years old.

International Members and Documents required for Travel: One Travel Team is a United States based Limited Liability Company. Our Membership can be purchased anywhere in the world, where not prohibited by local laws. Trips are not guaranteed to be suitable for your local market. Before becoming a member it is your responsibility to check local laws, rules and legislation to make sure you are not in violation of any laws in you country. You might require an entry visa to some countries. It is your responsibility to obtain all required documents. You shall conduct your own due diligence, before becoming a Member, If you permanently residing in any country outside of USA. Furthermore, you confirm and agree that One Travel Team, its' agents, employees, officers, directors, managers, service providers, vendors, collaborators, contractors, licensors, suppliers, transmitter of

information of the above parties have no liability for any damages physical, financial, legal, punitive or any other type of damages you might endure by becoming a Member. **DO YOUR DUE DILIGENCE BEFORE BECOMING A MEMBER!**

Authorization and Payments: You authorize One Travel Team to charge your credit or debit card or any other form of payment using the account identified in your application. One Travel Team will use this method of payments to charge for the Membership fee or Voyago Pro Membership Monthly Fee. You authorize One Travel Team, LLC to charge you credit or debit card monthly in the event if your internal account falls below minimum required for the payment of your monthly fees. You can unlink your credit or debit card in your back office.

If you pay by credit or debit card, you hereby confirm that you are an owner signor or authorized user of the credit or debit card or any other account used for the payment. You certify that you understand and agree that the transaction contemplated by this purchase consists of the Membership Fee and/or recurring Voyago Pro Membership Monthly Fee until the membership revoked by notice in writing in accordance with these Terms and Conditions.

Your Right to Cancel: Your membership will remain valid until you send us a cancellation request thru back office or, (1) you cancel by sending a written notice of cancellation of your membership by registered mail to 4923 E Abraham Lane, Phoenix, AZ 85050 or by e-mail to onetravelteamllc @ gmail.com or (2) cancelled by One Travel Team, by sending a written notice of cancellation of your membership to you by registered mail to the address held on file for you with Us or by email to the email address held on file for you on the date of the notice. Notice to One Travel Team must include your signature, printed name, address and your Membership Identification Number. Your Voyago Pro Membership will also be cancelled within three (3) business days, if your payment for Voyago Pro monthly membership fee did not go thru on the invoiced due date, or if any information provided by you in your application is false, inaccurate or fraudulent. One Travel Team must receive notice of cancellation at least five business days prior to scheduled payment date on your account. If a cancellation notice received less than five business days before the scheduled date of the payment, the cancellation will take place during the month following the month in which One Travel Team received the notice of cancellation. After cancellation by either party Member must cease using the Privileges of membership and the website starting from the next scheduled payment date. You can cancel the membership without penalty or obligation, within five business days from the date of your application to become a member and get a full refund. Kentucky Residents: If you reside in Kentucky, you can cancel the membership without penalty or obligation within thirty days from the date of your application and get a full refund. If you cancel after thirty days, you will be entitled to receive a prorated refund without deduction for the privileges you have used.

Virginia Residents: If you are residing in Virginia, you have the right to cancel your membership before midnight of the seventh calendar day after this agreement becomes valid. If the seventh calendar day falls on a Sunday or legal holiday, your right to cancel this agreement will expire on the day immediately after this Sunday, or legal holiday. In case of cancellation, One Travel Team will refund to you any payments made by you for the Membership under this Agreement within forty-five days after We receive notice of cancellation. In any case, One Travel Team may retain the payments made for specific travel services if they were used. Refunds will be made by crediting the credit card account, if a credit card was used to make the payment. Any Member permanently residing outside of United States of America may cancel within five business days.

Limits of Liability: Liability of those parties for damage caused to a member shall not exceed the amount of membership fees paid by the participants. One Travel Team, its' agents, employees, officers, directors, managers, service providers, vendors, collaborators, contractors, licensors, suppliers, transmitter of information of the above parties shall not be liable for any damages direct, indirect, punitive, incidental, special or consequential that result from: use or inability to use the website; any inaccuracy, error, delay or omission of any information or the transmission or delivery of any information; any negligent or reckless act or omission; or any force majeure event.

Indemnification: One Travel Team, its parent, subsidiaries or associated or affiliated companies, and their directors, officers, owners, employees, assigns, and agents, shall not be liable for, and you hereby release One Travel Team and its Associates from, all claims for consequential and exemplary damages. As a Member, you agree to comply with the Member code of conduct when travelling as a Member. You further agree to indemnify One Travel Team for any liability, (including attorney fees), damages, fines, penalties, or other awards arising from your conduct when travelling as a Member.

One Travel Team may at any time set off any liability of the Member against any liability of One Travel Team, whether either liability is present or future, liquidated or unliquidated, and whether or not either liability arises under these terms and conditions. Any exercise by One Travel Team of its rights under this section shall not limit or affect any other rights or remedies available to it under these Terms and Conditions or otherwise

Notification of change in privileges and services: One Travel Team provides certain service itself and / or through affiliated entities, as well as contracts Vendors and Collaborators to provide services and privileges to the members. Those services, privileges and benefits will change from time to time. One Travel Team will provide updated information on the benefits available through its website and by notification to the members at all times.

Restrictions of use: The membership can only be purchased in the name of a natural person. One Travel Team does not accept applications for membership in the names of business entities, partnerships, trusts or for the multiple names.

Services, privileges and benefits can be ordered and used by any member and one more adult aged 18 years or older who resides in the same household as a member, including the spouse, civil partner or another person.

You also agree that One Travel Team making every effort to bring you the best available price, but this price may be higher than originally announced price due to the limited availability of resources. Each trip or travel package booked subject to booking conditions and cancellation policies applicable to each specific booking, which may include restrictions imposed by Vendors and Collaborators, such as minimum or maximum age requirements, travel insurance and visa requirements. It is your responsibility to make sure that you are able to fulfill conditions of the reservation, including any such restrictions or requirements before booking. One Travel Team is not responsible if you fail to comply with such restrictions or requirements, where you have been warned about them on or before booking.

Transfer of the Membership. Membership is unique and personal to you as a member. You cannot assign, encumber, transfer or in any other way dispose any of your rights or obligations without our consent. In the event of death of the person on behalf of whom membership is held, this membership will terminate automatically

Vendors', Collaborators' and other Service Providers' Terms and Conditions. These Terms and Conditions should be read and followed in conjunction with the terms and conditions of each Vendor, Collaborator or any other service provider. The booking, acquisition or use of all goods and / or services subject to the terms and conditions of the Vendor supplying such products or member' services.

Jurisdiction: These Terms and Conditions shall be under jurisdiction with accordance with the laws and statues of state of Arizona, unless there are conflicting law rules.

Intellectual Property: Any downloadable content from the Web site is intellectual property of the One Travel Team or its' licensors, vendors, suppliers, service providers, collaborators or affiliated entities and protected by copyright law. Use of the copyrighted materials is regulated by the terms of use of the Internet Portal.

Copying or reproduction of the content or any copyrighted material of the Internet Portal is strictly prohibited.

You are granted a limited, non-transferable and non-exclusive license to use the copyrighted materials, documentation and other content of the Internet Portal necessary to access, explore and otherwise use the Web Site in real time and to use the materials, privileges, services on the Internet Portal in a manner consistent with these Terms and Conditions.
